This letter is in response to the following budgetary reprogramming request submitted by various government agencies through the Office of Management and Budget ("OMB") to the Financial Oversight and Management Board for Puerto Rico (the "Oversight Board") for review and approval.

After careful review of the request and the supporting documents, the Oversight Board makes the following determination:

1. 2025-0008M Assignments under the custody of the Office of Management and Budget (017) - Interagency transfer from Assignments under the custody of the OMB for various government agencies and public corporations to cover the FY2025 Christmas bonus. Also, various reapportionments from payroll and operating expenses in the FY2025 General Fund and Special Revenue Fund Certified Budgets for several government agencies to cover the FY2025 Christmas bonus. Finally, prior year fund release and fund extension until February 28, 2025, of FY2024 Special revenue Funds undistributed appropriations account of the General Court of Justice to partially cover the FY2025 Christmas bonus

Observation: The Oversight Board approves the interagency transfer in the amount of \$36,839,475 from FY2025 General Fund payroll appropriations under the custody of the OMB for various government agencies and public corporations to cover the FY2025 Christmas bonus. The Oversight Board also approves various reapportionments in the amount of \$12,607,534 from payroll and operating expenses in the FY2025 General Fund and \$53,848 Special Revenue Fund Certified Budgets from several government agencies to cover the FY2025 Christmas bonus. Moreover, the Oversight Board partially approves

the reapportionment, prior year fund release and fund extension until December 31, 2024, in the amount of \$164,280 of FY2024 Special Revenue Funds undistributed appropriations account of the General Court of Justice ("GCOJ") to cover the FY2025 Christmas bonus for judges. Finally, the Oversight Board denies the reapportionment, prior year fund release and fund extension in the amount of \$1,857,236 until February 28, 2025, of FY2024 GCOJ undistributed appropriations account to cover the FY2025 Christmas bonus for GCOJ employees, as the only eligible personnel for the additional \$400 bonus are the judges and an extension of the approved funds until December 31, 2024, should give GCOJ enough time to pay the bonus to the corresponding judges.

Furthermore, OMB shall allocate the above-mentioned amounts to the appropriate PRIFAS accounts and communicate their current budgetary allocations by cost object to the agency.

We trust the foregoing answers the requests identified herein and look forward to continuing our work together for the benefit of the people of Puerto Rico.
