Observation: The Oversight Board approves with observations the interagency transfer in the amount of \$43,132,782 as follows: \$20,313,302 from FY2024 funds and \$22,819,480 from FY2025 funds under the custody of the Department of Treasury to various government agencies to cover the payment of the Upside Participation Bonus for affiliated and non-affiliated government employees. Also, the Oversight Board approves the prior year fund release of \$20,313,302 until June 30, 2025, from FY2024 accounts of various agencies to make the corresponding payments to non-affiliated employees. The approved amount is \$57 over the amount requested by the government to account for rounding differences.
